# MINUTES OF THE ANNUAL MEETING Held on January 30, 2021 at 2:00 pm at the Clubhouse and on the Zoom system

# 1. Election of a Chair for the Meeting

The election of Andre Mongrain as the chair of the meeting was proposed by Jean-Claude Goyette (unit 335), seconded by Yvan Girard (unit 223) and unanimously approved.

#### 2. Quorum

A quorum was met. The registration confirmed that 284 members were present (5 in person, 79 using Zoom and finally 200 retained proxy) at the meeting, thereby exceeding the minimum requirement in Article 2.3 of the *Amended and Restated By-Laws* for the presence of members having at least 33 1/3 of the total votes in the Association. Here is the detail of the actual attendance:

In person attendees: 5

Via ZOOM attendees:79

Retained proxies: 200

Total proxies received: 283

One owner attended via Zoom without returning a proxy, to make the 284 totals.

These statistics demonstrate the importance of proxy solicitation and for the owner to return them.

There was one disregarded proxy it was received post 2.00 pm on the date of the meeting it is not part of the statistic.

### 3. Proof of Notices of the Meeting.

The Secretary produced two affidavits sworn by Stacey Casey, Manager, confirming that the two notices of the Annual Meeting were mailed, hand delivered or electronically transmitted to owners in accordance with the requirements of Section 718.112 of the Florida Statutes. # 4. Approval of the Agenda

The President indicated that the agenda should be amended to clarify item 7. This item is going to be information only on the resolution concerning the modified use of the working capital reserve which was voted on by the Board of Directors' minutes before the annual meeting in the preceding board meeting;

"It is moved by \_\_\_\_\_ and seconded by\_\_\_\_ and unanimously approved that usage from the Working Capital Reserve be restricted to the following situations:

- 1. The payment of a portion of the insurance policies premium. The amount used for this purpose needs to be refunded by the operating account before the end of the fiscal year (October 31) in the year it was borrowed.
- 2. Funds can be used from the Working Capital Reserve, following a vote of the owners for a special project in accordance with the Association documents.

Conditions and reimbursement to the Working Capital Reserve of such usage needs to be included in the voting documents.

3. In a case of emergency, the Board of Directors is authorized to use funds available in the Working Capital Reserve. It needs a formal communication to the owners before use and the amount needs to be reimbursed within 30 days of the last usage date of the Working Capital Reserve under this article, either following an insurance settlement, the collection of a special assessment or from a transfer from the operating fund.

This motion is valid until the Board of Director's meeting to be held on January 29, 2022 at which meeting a new motion will be voted on. If no motion is tabled, then this resolution remains in full force and effect."



#### MODIFICATION REQUESTS - COMMITTEE ACTIVITY JAN 2020 - PRESENT

Our BOD Modification Requests Committee has 4 members:

- Marian Petrescu
- Jean-Claude Goyette
- Michael Shane
- Celine Poissant

The main goal for this Committee's activity is to evaluate all the requests, making sure that what every owner is asking for as a "Modification" is complying with our Association Condo Document's rules and regulations, is not affecting in any way the existing infrastructure (electrical or cables, water pipes, etc.), the privacy of the neighbors, not abusing the "common area" and also not changing or affecting the Waterside's architectural style and standard.

Within the year 2020 and Jan 2021, our Committee received 20 requests, mainly for windows and sliding door replacement (13x), Replacing tiles on Patio (1x), Patio extension (1x), Relocate A/C unit, Tiles on balcony (1x), Landscaping change (1x), Replacing front door (1x), Window protectant film (1x), Extended Florida room (1x).

Most of requests have been approved, with some recommendations, case by case:

- Requesting Contractors to get permit from the city
- Area of location or extension
- Locating elements of infrastructure in working areas
- Restriction/Limit in size
- Type of material to be used

As a reminder for all the owners: All the Modifications are contributing a lot, as improvements in the general look of our site and also the value of our properties, so our Board is strongly encouraging the owners to continue all these investments.

# PRESIDENT REPORT FOR THE FISCAL YEAR 2019/2020

One more year and what a year,

We did have the choice of the calendar year versus the fiscal year, we selected the fiscal year that runs from November 1<sup>st</sup> 2019 to October 31<sup>st</sup> 2020, this is more encouraging as we did experience close to 4 months of normality, post March 1<sup>st</sup> 2020, nothing was normal. The only thing we did need to stress was wear a mask, maintain social distancing, wash your hands, follow the protocols in place and make sure Board members enforced the various orders and the CDC guidelines.

Financially we have refunded most of the amount used for the TV conversion from analogue to digital, initiated the replacement of our Ficus bushes around the perimeter of the property, and we hope that we can complete this task over the next three years. We should complete Miner Road and one more section on the west side of the property during the current fiscal year. We have respected the budget objective. Even if the season peak for social activities was cut short due to the Covid-19 virus, it was a success, thanks to Guy Hamel and its committee members and the group of volunteers that support the various activities.

I want to wish a sincere thanks to retiring Board Director Marian Petrescu for his past 12 years of service to the community, he did ensure a constant uniformity on the various requests for modification. We also wish to thank Mrs. Celine Poissant for her service as Director for the past 4 years. To our office and maintenance staff also my thanks, for a somewhat complicated year due to the Covid and also for supporting me, I am sure they were not too happy to see me all summer long. Thanks to the Board members who did have to contribute from the distance. A special thanks to Normand Cadieux, Jean Claude Goyette and Stacey Casey who set us up on ZOOM, which probably will remain a tool for the future.

Waterside residents have been fortunate with not being too severely impacted by the Corona virus, with only 3 cases that did not require hospitalization and we hope it will remain that way. There is protocol in place for every activity, thanks you to all who are abiding by the procedures. So far, we have not been able to open the library, we may try to do so. Waterside so far has been lucky with the vaccination process, we have over 20 residents, either permanent or snowbird owners, that received the first dose of the Moderna vaccine, they are also confirmed for their second dose. Other residents that have some sort of confirmation that they are in the queue. The program that the State has put in place is hard to understand, does it limit snowbird or not, the rules that they have promulgated are so wide that it is hard to understand if there will be real restrictions on snowbirds.

Let's hope that we will be all here next season and maybe for a longer period during the fall, as your days outside Canada would have been very limited so far in 2021, and that you can contribute to the Florida economy. I want to conclude with my thanks for your support during the fiscal year, the implementation of the Covid-19 various protocols and regulations was not an easy one. Please remember that your Board has legal and insurance responsibility, in addition to responsibilities to the whole community. In order to maintain our Annual meeting tradition, have a good glass of wine at home!

As a conclusion, wear a mask, maintain social distancing, wash your hands and respect your neighbors, who may have special health conditions.
