5. RESOLUTION FOR TRANSFER OF POSSIBLE OPERATING SURPLUS FOR FISCAL YEAR 2022/2023

It was proposed to allow the Board of Directors to transfer funds, if at the end of the fiscal year 2022/2023 there is a surplus of revenues over expenses of more than \$5,000.00, the said surplus would be transferred to the Working Capital Reserve (account # 2545).

This is necessary due to growing cost of the insurance, at the current rate of transfer, i.e., \$20,000.00 it is insufficient, to create appropriate funding for the payment of the premium in May of each year.

The vote was proposed by Jean-Luc Beaudoin and seconded by Daniel Laviolette; the board of directors unanimously voted to adopt the said resolution.

6. RESOLUTION FOR THE TRANSFER OF \$42,000 FROM THE OPERATING PAINTING BUDGET ACCOUNT #420 TO THE PAINTING RESERVE BUDGET ACCOUNT #2515

It was proposed to allow the Board of Directors to transfer the budget allocation that was set up under painting (account #420) part of the operating budget for the fiscal year 2021-2022 to the Painting Reserve account #2515.

On reception of quote for the year 2021/2022 for painting, cost per door went up substantially, the Board made the decision to postponed by one year the painting program and fund not to be used for other purposes than painting. The increase in the reserve balance will help to stabilized future years cost.

The vote was proposed by Michael Shane and seconded by Daniel Laviolette; the board of directors unanimously voted to adopt the said resolution.
