1. Quorum

2. Approval of the Agenda

4. Approval of the contracts awarded since the last Board meeting

7. Insurance update

President Andre Mongrain gave the latest information and costs relating to that subject. He talked about estimates of the cost of our next insurance premiums.

President Andre Mongrain gave the latest information and cost relating to that subject. The list for the past year is available on our website and a new list will be posted by the end of March.
