3. In a case of emergency, the Board of Directors is authorized to use funds available in the Working Capital Reserve. Such amount needs to be reimbursed within 30 days of the last usage date of the Working Capital Reserve under this article.

This motion is valid until the Board of Director meeting to be held on January 25, 2020 at which meeting a new motion will be voted;
